 Students that received tutoring in the summer showed increases in test scores.

# B. Superintendent/Principal Report

The Superintendent reported:

- A response is in process to a special education complaint filed against the CAVA San Diego charter school.
  - She attended mediation for one CAVA student.
  - A new head of school will be announced soon for CAVA@SD and Insight@SD.
  - Site Council elections will be taking place soon.
  - CELDT testing is complete.
  - Rosetta Stone will be used for EL and World Language; 5 licenses remain.
- Discussions about the Julian High theater building and the SEA Program have taken place.
- An extension was granted by the County to add an additional sidewalk to the Par Course grant.

# A. Student Transfer requests for 2016-2017 school year.

**PROPOSAL:** To approve the transfer requests.

# B. Approve method for making a government board member appointment, as required by EC §5328, to a full term seat expiring in 2020

**PROPOSAL:** To approve the method for making a government board member appointment when no one has been nominated for the position.

**BACKGROUND:** A full term seat is open because no one has been nominated for the position. When no person is nominated for a position, Education Code 5328 requires the governing board to appoint a qualified person at a board meeting prior to the election. The board must publish a notice of its intention to appoint in a newspaper

and the appointee will be seated at the organization meeting of the board as if elected at a district election.

**BUDGET IMPLICATIONS: None.** 

**ACTION(S):** The Board voted to fill the vacancy by appointment.

# F. Use of Facilities - Christmas Carol/Scott Kinney

**PROPOSAL:** To approve the use of the SVS Creative Arts Room for Christmas Carol rehearsals.

**BACKGROUND:** SVS allows for the Creative Arts Room to be available for public use when it does not conflict with SVS functions. The Christmas Carol Production has requested rehearsal space. They will provide hold harmless agreements for each participant.

**BUDGET IMPLICATIONS:** A donation will be made by a community member towards in-kind services. Spencer Valley Supports the arts and students usually participate in the production.

In November of 1979, the California electorate adopted Proposition4, commonly called the Gann Amendment, which added Article XIII-B to the California constitution, to establish maximum appropriation limitations, commonly called "Gann Limits," for public agencies, including school districts.

**BUDGET IMPLICATIONS:** Establishes appropriation limitations to the budget. **ACTION(S):** The Board adopted the 2016-2017 Gann Limit.
