A. Local Control and Accountability Plan

The Board was presented information about modified goals for the 18-19 school year that were discussed at the Parent Advisory Committee meeting. New actions and services include providing a coach to support English Learners and ability of teachers to recognize when and how to differentiate work, scaffolding tasks so the assignment fits each child's need, and school-wide behavior supports based on the BEST Behavior workshop. Key features of the program are: 1) creating clearly defined and agreed upon rules in classrooms and transition areas; 2) implementing a combination of extrinsic and intrinsic rewards for positive reinforcers for every negative interaction; 3) structuring/adapting work to a 75% completion rate (highly structured to gradual release of teacher responsibility) and; 4) use monthly reflection periods to analyze continuing areas of need and alleviate potential bias.
