- An example of a family tree student project from the 1st-2nd grade classroom. The Superintendent reported:
- The first fire drill of the year was completed.
- BTSA teachers attended their first classroom observations at other Districts.
- During the planning day on October 5th, the Teachers 1) planned events for the rest of the trimester, 2) discussed and planned the winter show with the music teacher, 3) met with the school psychologist, 4) examined student needs and defined supports and the schedule for services, and 5) explored CAASPP data from Spring 18 to design appropriate instructional goals.
- B. Superintendent/Principal Report
 The Superintendent reported:
- The County Office of Education ELCAP After Action visit was on October 8th. The County Office will be supporting SVS with Designated and Integrated ELD implementation, History-Social Science and Next Generation Science text book adoptions, and training for teachers in the writing of authentic performance tasks.
- The first LCAP Parent Advisory Committee and School Site Advisory Council meetings will be held on Thursday October 18th. Goals are being developed with the assistance of the teachers.
- The books "Who's Doing the Work?" and "Emotional Poverty" will be revisited for staff book study.
- Student progress reports were sent home.
- ELD Redesignation cut scores will be locally defined for 18-19.
- Special education compliance/case management at the charter schools will need to be monitored more closely due to the CASEMIS to CALPADS conversion.
- A meeting was held with BTSA teachers to provide support for their first assignment.
- Lieutenant Blankenbaker, of the Sheriff's department, was invited to the all staff disaster planning meeting.
- Student supports are in place for students that are below grade level or English Learners.
- A meeting of local region superintendents will be held on October 11th.
- Grant writing, in conjunction with the SDCOE Sheiveh Jones, for a regional Special Education teacher is in progress.
- C. Enrollment
- Enrollment is 41 students 22 in Old School House and 19 in Ritchie Hall
- August Attendance was 97%; September Attendance was 95%; YTD Attendance through September is 96%.
- D. Curriculum and Instruction
 - The Superintendent reported:
- The third installation of Putting it All Together (PIAT), the LCAP workshop offered by SDCOE, starts on October 16th.
- The Disaster Preparation Meeting is on October 11th. Active shooter training needs to be scheduled.
- E. Facility Update
 - The Superintendent reported:
- The architects will be visiting the preschool at Clover Flats for research purposes.

- Dave Boyer repaired the front of the Old School House. All the trim needs to be painted again.
- Trash day was changed and Ramona Disposal will be charging for recycling.
- F. Business Report

The CBO reported:

- CASBO Fall Classic Professional Development is on October 12th.
- The Auditor will be completing the 17-18 Audit the week of November 5th.
- The 18-19 Adopted Budget Approval letter was received from SDCOE. The District has met the necessary requirements, per EC 42127.
- The yearly E-Rate informational meeting with consultant Nancy Von Langen Scott is being scheduled.

VII. INFORMATION AND STUDY

A. Local Control Accountability Plan Goals

The Superintendent discussed Spencer Valley's goals for the 18-19 school year. For English Language Arts, improving writing is a focus. The approach will be two fold — to train teachers in writing authentic performance tasks and to help students improve in completing ELA and mathematics performance tasks. In addition, teachers and parents will focus on improving fundamental mathematics skills. Mathematics, the focus is on improving automaticity.

B. Site Plan for Student Achievement Goals

The Superintendent stated the academic goals are the same goals as in the LCAP. Positive Behavior interventions and Supports (PBIS) will be implemented. Law enforcement will be assisting in updating the Safety Plan.
