B. Approve District and County Wide Plans for Serving Expelled Students

PROPOSAL: To approve the District Plan and the County Wide plans for Serving Expelled Students

BACKGROUND: Per Ed Code 49826, each County superintendent of schools in counties that operate community schools shall develop a plan for providing educational services to all expelled pupils in that County. The plan shall be adopted by the governing board of each school district within the County and by the County Board of Education. The plan shall enumerate existing educational alternatives for expelled pupils, identify gaps in educational services to expelled pupils, and strategies for filing those service gaps. Per Ed Code 48916.(1) at the time of expulsion, the governing board shall ensure that an educational program is provided to the pupil for the period of the expulsion, but only the extent funds are appropriated for this purpose in the annual Budget Act or other legislation, or both. As such, the Spencer Valley governing board must approve the District's individual plan.

C. Approve Expanded Learning Opportunities Grant Plan

PROPOSAL: To approve the District's Expanded Learning Opportunities Grant Plan.

BACKGROUND: AB 86 provided for a \$4.6 billion Expanded Learning Opportunity Grant. In order to use the funds, the District must develop and approve a plan for the use of the funds to implement supplemental instruction and support strategies for their students. Local governing boards must adopt the Expanded Learning Opportunity Grant Plan (Plan) on or before June 1, 2021. Under EC Section 43521(b), the funds are to be used to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups: low-income, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, and other students identified by certificated staff.

BUDGET IMPLICATIONS: \$27,233, with \$2,723 restricted to paraprofessionals. **RECOMMENDATION(S):** To approve the Expanded Learning Opportunities Grant Plan.

D. Approve Comprehensive School Safety Plan

PROPOSAL: To review and approve the comprehensive school safety plan.

BACKGROUND: The comprehensive school safety plan includes information on being prepared for emergencies and maintaining safe and secure school environments. AB1747, School Safety Plans, requires the school site council or safety committee to consult with the fire department and other first responders in addition to currently required entities. It requires updates to the plan be shared with the law enforcement agency, the fire department, and other first responders. It must also include procedures for conducting tactical responses to criminal incidents.
