BACKGROUND: Each of the Districts in the MOU need of a school psychologist on a parttime basis. Warner offered to hire Brown as a certified school psychologist for the 21-22 school year under a joint employment and cost-sharing agreement. Spencer Valley will benefit by having a school psychologist on site and ready when the need arises.
