III. REPORT SECTION – Oral

A. Superintendent/Principal Report

The Superintendent reported:

- The owner of The Old Goat brought 2 goats to the school, and presented information about goats, goat milk, and goat yoga to the students.
- Parent/Community Engagement meeting dates have been set for the year. Meetings will begin in November, and will alternate monthly between morning and evening meetings.
- Red Ribbon Week is next week. Activities are planned for each day, culminating with a class presentations and graduation.
- November 5th is family movie night. A movie will be shown outdoors and popcorn and hot chocolate will be provided.
- B. Enrollment
- Currently have 30 students, a new 1st grader enrolled.
- Attendance to date is 96.52%. If one student is absent, attendance drops by 3.3%.
- Chronically absent and tardy students received a letter regarding attendance.
- C. Curriculum and Instruction
- On 10/14, Cynthia Craft from SDCOE began training teachers with Guided Reading Plus.
 Guided Reading Plus is a literacy intervention for grades K-8. Two more sessions will be

held, in which Cynthia will model what intervention looks like with a small group of students.

- Teachers have decided on science curriculum to pilot. Grades K-3 and 5 will pilot TWIG science, grade 4 will pilot Discovery Education, and grades 6-8 will pilot Science Bits.
- D. Facility Update
- Annex interior painting is complete, and outside sidewalk cement has been poured.
- Sloan has provided a quote for upgrading the bathrooms, including toilets, sinks and faucets.
- E. Business Report
- October 31st is the end of the first budget reporting cycle. Funds in the state's adopted budget that will be incorporated at first interim include expanded learning, educator effectiveness, kitchen equipment, and Special Education ADR and LR.
