The Superintendent reported:

- Four snow days were used in February due to the weather.
- She attended her first in person Superintendent's Roundtable meeting last Friday. The
 afternoon was spent with small school districts superintendents where they shared
 information with us about the Expanded Learning Opportunity Plan Grant and Universal
 PreK.
- The parent newsletter was sent home on Monday with a short section on information for parents about masks.
- An applicant was interviewed to be our new cook. She has filled out all the paperwork and we are hoping that she will start next week. The pay will be \$25 an hour.
- All of the classified employees are dedicated individuals that work very hard to support Spencer Valley and they are an extremely important part of our team. We would like to bring to the table in April raises for all of our classified staff.
- A preschool teacher applicant will be interviewed on Friday. She is new to Julian and has experience as unit leader and site supervisor for YMCA. She also worked at the SDCOE as a youth development assistant. She has a B.A..
- Another preschool candidate reached out today looking for more information about the preschool position. She is currently working in a day care in Poway and is finishing up her associates degree in May.

- Shakespeare performances will be held on April 26, 27 and 28. April 26 and 28 will begin at 6PM and the dinner theater event on the 27th will begin at 5PM. Postcards will be sent out this week to let the community know. Practices are going strong. Our director is at the school M, T, W and F to work with students from 1:15-3:40. She stays during Homework Club to work with students, too.
- The Gulls Hockey Outing is this Saturday at 7PM. Spencer Valley was able to get discounted tickets for all families and friends who wanted to attend. Spencer Valley tickets are all together in one section. We have about 34 people who will be attending.
- Another survey will be sent out in the next week for families in order to get input from them about a longer after school program that has been mandated to begin at the start of the next school year. Each public school must offer a 9 hour day. A plan is being drafted for board approval, but input is desired from our families on their preferences.
- Ms. Allyson's class will be participating in the Daffodil Show in Julian in March. They
 will provide artwork and will show daffodils.
- The Julian Women's Club reached out to me to see if Spencer Valley would provide artwork for the Wildflower show in May.
