III. REPORT SECTION – Oral

A. Staff Sharing

- Teacher Shalom Covert shared the principles of Responsive Classroom (social emotional learning and academics) and how she implements it in her classroom. Daily activities include morning meeting, quiet time after lunch, modeling, and closing circle.

B. Superintendent/Principal Report

The Superintendent reported:

- A sign up sheet for our 10/21 PL day with Julian Union Elementary was sent out today. We are offering sessions about trauma informed practice, Play Math, inclusion strategies for all learners, developmentally appropriate practices for PK/TK, beyond google basics, restorative practices/PBIS, digital escape rooms, general education and special education collaboration. Teacher choose 2 and then will have collaboration time in the afternoon. Classified staff choose one and then will work on PBIS/Restorative practices in the afternoon. Breakfast and lunch will be provided.
- Currently working with 6 students in intervention did not get chosen for the Heroes grant but am part of the research and assessment and will receive a small amount of money to purchase materials. I have the option to be one of the chosen for next year
- ELOP Update Zumba has been canceled, Spanish is not working as the students need more physical activity after school. Yoga is a hit and kids loved zumba, too.

- Wednesdays will turn into floor hockey (today was last day for Spanish). Hoping to get martial arts started soon. Looking for other games that we can work with students on.
- Thursday staff meeting will be the first time we meet with teachers about the salary schedule
- Began MTSS process with teachers last week. One Thursday afternoon each month teachers will meet with me to talk about students that they have concerns about and any other concerns they may have. I am thinking about offering this to classified staff, too.

C. Enrollment

- 44 students currently enrolled.
- Attendance letters were sent home on Monday for tardies and missing 3 or more days of school.
- September attendance was 95.28%, with YTD attendance at 96.12%.

D. Curriculum and Instruction

- The Superintendent is working with teachers at staff meetings on writing, including a goal for what the focus should be at each grade level, and a whole school writing assessment.
- Who is "Spencer Valley" staff is working on choosing words that will be defined as the expectation of who we want to be. Current staff words include integrity, inclusive community, compassionate and student engagement. Students and parents will also choose words. Students, families and the board will also choose words. Ultimately, the chosen words will define who "Spencer Valley" is.

E. Facility Update

- Community Care Licensing finally answered questions regarding the preschool paperwork. Budget does not need be completed, and the licensee is the district. Paperwork can now be completed and turned in.
- The Kitchen floor will be resurfaced next week.
- The notice of completion was filed and accepted by DSA.

F. Business Report

- Auditors will be completing field work on Oct. 20 and 21.
- One time block grants, including \$31,503 for Learning Recovery \$18,677 for Arts, Music & Instructional Materials, will be added at First Interim budget reporting.
